No sooner than 15 minutes prior to the meeting start time, you may dial in to the North Bergen Municipal Utilities Authority Board of Directors meeting dialing **1-888-484-2663** and entering **ACCESS CODE: 451 524** followed by the # (pound) sign. You will hear a 'beep' confirming that you have entered the meeting. Upon entry, members of the public are required to mute their line by pressing *6 on the telephone keypad. While muted, you will still be able to hear the meeting participants. When it is announced that the meeting is open for public comment, you may un-mute your line by pressing *6 a second time. To make a public comment, you must state your name and address for the record. At the conclusion of your comment, you will be asked to again mute your line by pressing *6 on the telephone keypad.

If at any time during the conference you need to raise the volume of your line, you may do so by pressing *4 on the telephone keypad. If you require operator assistance, you may press *0 on the telephone keypad.
